- 4 Each winner will receive a certificate in recognition of the award.
- 5- Letter of achievement can be written and provided upon request from the authors of the winning papers.

#### Award Participation Terms & Conditions:

- 1. The research topic must be; economically viable if applied in chemical industries.
- 2- Be useful to the scientific community.
- 3. Be innovative and fulfill the foundation for accepted scientific research paper conditions.
- 4. The research must not have been published previously and must not be submitted to another award or competitions at the same time.
- 5. It must present important and up-to-date scientific proposals and recommendations.
- 6- The candidate for the competition is required to submit; photos, data and evidence of the content of the research.
- 7- The research topic should be innovative and not a review of a published scientific data.
- 8- The participating research should not have been published elsewhere or enter and won any previous competition.
- 9. The publishing rights of the winning research project are owned by the Emirates Chemical Society for a period of 2 years from the date of the announcement of the results, and may not be published or disposed of by the authors or presented in a conference or a symposium without a written permission from the Society.

## Research Assessment:

- 1. The Emirates Chemical Society will forms an arbitration committee that shortlist the applications submitted for the competition.
- 2 The committee evaluates the submitted scientific production based on criteria set by the committee for this purpose before reviewing the submitted works and initiating the evaluation.
- 3. The committee will submits their final recommendations for the winning research project.
- 4 Prior to the announcement of the result, potential winners will be notified to allow arrangement to be made to receive the prize

### Paper Format:

#### The paper must be written in English and follow these requirements;

- Length: Paper should be no longer than 20 pages include all charts/graphs, references, and any appendices.
- 2- Appearance and Format: Font size is Times New Roman 12.
- 3- Papers must be submitted in MSWord, double spaced Margins of 1 inch
- 4 Title Page and Abstract: The title page must include the author's name and affiliation
- 5- An abstract of no more than 300 words must follow the title page.
- 6- Title and abstract pages are not included in page limits.
- 7 Page headers and/or footers should contain only page numbers and a shortened
- 8- To ensure anonymity, the authors and affiliation names, must not appear anywhere except at the title page.
- 9- Entry Forms: Papers must be submitted electronically via the UAE Chemical Society award link.

#### The research should consist of the following sections:

- Introduction to the study:
  - It includes the theoretical framework of the research, and the previous studies are part of it, and integrated into the body of the introduction without a separate title.
- The study problem, objectives and questions/or hypotheses must be included so as the importance of the research and study limitations (if any).
- Definitions Of all scintific terms.
- Study procedures: These include.
- The community and the sample size.
- Study methodology.
- Validity and stability of the tools, study instructions, the method used in the study, views, and discussion of the results, conclusions and future recommendations.
- The assessment and the scoring of the manuscript for the award will be based on the following criterion: Determining the objectives, and importance of the research, clarity
- of the research problem. The strength of the theoretical framework in supporting the research
- hypotheses. The research methodology and, the adequacy of its procedures.
- The suitability of its tools, and the methods of analysis use.
- The strength of the results and practical recommendations for the
- Clearly and comprehensively present the results of the analytical dis
- The scientific and practical value of the results reached through the re search and the extent to which they can be generalized.
- Integrity of style, language and organization.
